Please also include your E-Mail address or the E-mail of someone who will be responsible to forward much needed information to you. REMINDER: It is your responsibility to check the Web Calendar for upcoming shows.

Set up will begin on Friday June 9th, 2023 Competition will begin on Saturday June 10th, 2023 and depending on number of acts Awards may follow the Competition on Saturday. We are again offering the **Bravo Award** which will be the winner of the Triple Threat. A Triple Threat participates in any three of the four MAJOR TALENT CATEGORIES OFFERED: Voice, Dance, Acting, or General Variety. The performer must receive a Gold or Gold with Honors to qualify. The performer with the highest combined score will receive the Award.

Please note in regards to props. The act representative is responsible for placing all props for the performance on stage at State Finals. Louisiana Kids, Inc. will no longer provide stagehands to place props for acts. All solo and group acts have one minute to set up **AND** take off props, and all production numbers have two minutes.

MEMBERSHIP AGREEMENT / RELEASE OF LIABILITY

I have read and understand that to be chosen to participate in Louisiana Kids, Inc. shows I will abide by the Performer Show Guidelines and by the State Office. As a member of Louisiana Kids, Inc., I gladly accept this responsibility to set a wonderful example for my family, my audiences and my God. I completely understand that if I choose not to abide by the Performers Show Guidelines I will be choosing to remove myself from the Member Show Invitation Registry. I am ready and willing to share my talented gifts in as many places I am able.

Professionalism

I understand that in order to participate with Louisiana Kids, Inc., that I, the performer, as well as my family and friends must exhibit high professional demeanor and/or attitude at performances and competitions. I understand that Professionalism is determined by the following:

- Showing up on time to performance venues as indicated on the event calendar.
- Canceling a performance includes due diligence in contacting a show producer to inform him or her of my cancellation in advance of the scheduled event.
- Working well with and respecting the Board, members and volunteers during performances and competitions.
- Presentation and behavior on and off stage during performances and competitions.
- Cooperation and helpfulness during performances and competitions.
- Good, healthy, non-prima donna attitude during performances and competitions.

I understand that any behavior not deemed professional will be reported to the State Directors and the Louisiana Kids, Inc. Board Members for review, and such review may result in permanent dismissal from the Louisiana Kids, Inc. organization.

Show Performance Time - Time Limit Notice All Entertainers

Performance tracks are limited to 3 minutes 15 seconds. Tracks longer in duration causes Louisiana Kids, Inc., performance time to cross over into the next venue time performance or go over our half hour/one hour performance time slots. All CDs are to be labeled with child's name, name of song, and time.

Attire

- 1. Clothing: I agree to abide by the dress code as described under each event listed on the event calendar.
- 2. Shoes/Flip Flops: The rule now stands if it has a HEEL and is decorated in sequins/rhinestones it will be permitted. Flip Flops with NO HEELS and decorated with sequins/rhinestones will NOT BE PERMITTED OR CONSIDERED as proper performance attire.

Release of Liability and Hold Harmless Agreement

I, the performer, together with my parents and legal guardians:

- acknowledge that by entering the premises and participating in Louisiana Kids, Inc. related events that there are risks
 of injury, disability, death and/or loss or damage to person or property and voluntarily and knowingly assume any and
 all risks;
- acknowledge that there are risks of exposure, directly or indirectly, to communicable diseases including but not limited to the virus "severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)", "COVID-19" and/or any mutation or variation thereof and voluntarily and knowingly assume any and all risks;
- agree to release and hold harmless Louisiana Kids, Inc., its Board Members, members and volunteers with respect to
 any and all communicable diseases, injury, disability, death and/or loss or damage to person or property, including if
 such injury or damage is due to the negligence of Louisiana Kids, Inc. representatives. Should Louisiana Kids, Inc.
 representatives be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold
 such harmless for all fees and costs.
